It will not be revealed, directly or indirectly, to any officer, employee, or director of either the Company or Biglari Holdings, except as otherwise required by law. You should therefore feel completely free to instruct the Record Keeper to vote your shares in the manner you think best.

Because of the time required to tabulate the vote, your voting instruction must be <u>received</u> by Internet, phone or mail no later than 5:00 p.m. Central Time, on Tuesday, November 13, 2012.

The Record Keeper cannot ensure that instructions received after the cut-off time will be effected. Therefore, it is <u>very important</u> that you act promptly and return your instruction so that it is received before this time.

Please vote. Your instruction to the Record Keeper on how to vote your shares is an important part of your rights as a Plan participant.
